### **BUDGET UPDATE**

### NOVA Academy-Coachella

Mark Hendrie from Delta Managed Solutions presented the Budget Update for NOVA Academy-Coachella. He reported that the current ADA for Coachella is 202, which is slightly above where it was at 2<sup>nd</sup> interim. Revenue increased by \$29,000 and there is a \$65,000 improvement over the 2<sup>nd</sup> interim. The 2016-2017 school year should end in a strong position.

The Board discussed the need for the Coachella campus to have additional restrooms and for the modulars to be upgraded. Lisa Hernandez, Principal, reported that the Coachella campus has only two staff restrooms. John Bowen, Director of Operations, said he is working on receiving quotes for upgrading the modulars and adding more restrooms. He will present quotes at the next Board Meeting.

## NOVA Academy-Santa Ana

Mark Hendrie presented the Budget Update for NOVA Academy-Santa Ana. He reported that the ADA reported at 2<sup>nd</sup> Interim decreased by 7 and the net revenue is \$75,000 less.

Carla Skaggs, Business Consultant, added that it is imperative to have a balanced budget. The Board discussed having a Special Meeting next month to discuss balancing the budget for Santa Ana. Karen Lester, Carla Skaggs, Renee Lancaster, and Mark Hendrie will plan a time to review and develop a 2017-2018 budget to present at the June Board Meeting.

Next, the Board discussed having a one-time off schedule salary increase for employees as a result of meeting specific performance benchmarks. Carla Skaggs reported that there are schools that have given a one-time payment to employees in the month of December. Carla recommended that NOVA Academy seek legal review. Sanford Otsuji, Board Chairman, asked John Bowen to conduct some additional research with NOVA Academy's legal team.

# LOCAL CONTROL ACCOUNTABILITY PLAN

NOVA Academy-Santa Ana

Kathryn McGillivary, Assistant Principal, shared the Local Control Accountability Plan (LCAP) goals and survey data collected from parents and students for NOVA Academy-Santa Ana. Some of the general findings from the survey data are that the school climate satisfaction is overwhelmingly high, students report feeling safe, and teachers are perceived to have high expectations of students. The goals included greater parental involvement, more students taking AP courses, and increased English and Math scores on the SBAC. The Board discussed the findings and gave their feedback on goals. The LCAP for Santa Ana will be approved at the next Board Meeting.

## NOVA Academy-Coachella

Lisa Hernandez, Principal, shared the LCAP goals and survey data collected from parents and students for NOVA Academy-Coachella. The goals are increased SBAC scores, greater parental satisfaction at parent events, greater school safety satisfaction, and increased dual enrollment eligibility. From the LCAP surveys, parents overwhelmingly reported that they are satisfied with parent events and they enjoyed the topics. Lisa added that a high percentage of parents come to the events. Parents also reported that students are struggling with math and bullying is an issue. The Board discussed the findings and gave their feedback on goals. The LCAP for Coachella will be approved at the next Board Meeting.

#### **BOARD RESOLUTION**

John Bowen, Director of Operations, provided an overview of the Safe Learning Environment for all Students Resolution for Board approval. He explained that the resolution is comprised of the school's current practices and policies in a single document.
