EXECUTIVE REPORT

Renee Lancaster, CEO/Founder, provided an update on NOVA Academy-Coachella for Principal Lisa Hernandez who was not present at the Board Meeting. She shared that new restrooms were built at the Coachella campus. There was a recent drop in attendance after it was announced that the federal program DACA will be rescinded. In response to the announcement, the school sent a Loop message to parents informing them that their students are safe.

Renee reported that Coachella's 2017 SBAC scores in ELA and math decreased. The school will have goals and action plans for the upcoming school year to improve ELA and math skills. The focus will be on campus wide campaigns, benchmark assessments, classroom observations, and data directed instruction. Renee added that teachers received professional development to improve learning in the classroom through Dennis Parker's presentation at the recent Professional Development Meeting in August. There is a new IO Assessment Program where students complete both online assessments and paper exams. This program will help create benchmarks. Also, teachers will have the opportunity to do "Treasure Walks" where they visit various classrooms and gather instructional ideas they can utilize in their own classroom.

Renee reported that the school will also focus on attendance this school year. Loop communication to parents, Attendance Awareness Counseling, and attendance competitions will be utilized to help improve attendance. Also, the school will issue SARB (Student Attendance Review Board) letters for students with excessive tardies and/or unexcused absences.

The Coachella campus will focus on increasing parent connection through Loop communication, parent surveys on desired topics, two Parent/Teacher Conferences per year (one in the Fall and one in the Spring), and personal phone calls. The school will also start having parent invitations to campus instead of campus suspensions.

Last, Renee shared that Coachella is offering more college courses and AP courses. Coachella received a \$30,000 grant from the Anderson Foundation. With the grant, the campus is now offering more college courses from Concordia University and one semester of a UCI course. With the added college courses and AP courses, the school has set up opportunities for students to receive support through office hours and Tutorial study hall.

Dr. Andrea Brumbaugh, Principal, presented an update on NOVA Academy-Santa Ana. She reported that SBAC scores increased the previous year (2016), but dropped this past year in both math and English. There will be improvements in Seminar classes to help students in math and English. Freshman Seminar classes will be taught by math and English teachers; the focus will be on developing writing skills and math skills. Junior Seminar classes will have students take one semester with a math teacher and one semester with an English teacher. The focus of the Junior seminar classes will be on SAT, ACT, and CAASPP preparation. Andrea reported that the Santa Ana campus has ongoing professional development for teachers based on John Hattie's research on teaching strategies from his book Visible Learning.

Andrea shared that the Santa Ana campus is working on improving attendance through Loop communication to parents, an Attendance Counseling Program, attendance competitions, SARB letters, and teacher behaviors in the classroom to encourage student attendance. The school will be increasing parent connection through such activities as Parent University, Coffee with the Counselor, personal phone calls, and many others.

The school has a new meal program vendor, Preferred Meals. Students have reported that they like the food. Staff is continuously monitoring the food for taste, temperature, and quantity to ensure student satisfaction.

Last, Andrea reported that Santa Ana provides dual enrollment for college classes at Concordia University, UCI (one semester), and Santa Ana College. NOVA Academy-Santa Ana now offers a Physics class. It increased its AP course offerings to 10 AP courses. This year, there are strategies in place to increase student success in AP courses, such as AP review sessions. Brenda Gonzalez, Board Member, commented to Andrea Brumbaugh that it would be helpful if the school had interns available after school to tutor students.

Dr. Sanford Otsuji, Board Chairman, said it is great to see more kids taking AP courses and he commended Principals Lisa Hernandez and Dr. Andrea Brumbaugh and the teachers for everything they are doing for NOVA Academy.
