#### **BOARD UPDATE ON SPECIAL EDUCATION FOR 2020-2021**

Renee Lancaster, Chief Executive Officer, and Trevor Garrett, Proposal Coordinator/Data Impact Analyst, presented to the Board an update on special education for 2020-2021. Currently, NOVA Academy-Santa Ana receives special education (SPED) services through Santa Ana Unified School District's single-district Special Education Local Plan Area (SELPA); NOVA Academy-Coachella receives services through its member district, Coachella Valley Unified School District, which is a local education agency (LEA) within the Riverside County SELPA. Both the Santa Ana and Coachella campuses are officially withdrawing from their current SELPAs. Beginning in 2020-2021, NOVA Academy will be 100 percent responsible for all special education needs. Renee Lancaster and Trevor Garrett met with three potential SELPAs: El Dorado County, Los Angeles County Office of Education (LACOE), and Riverside County. Board Members discussed the information in the presentation and agreed there are benefits to NOVA serving as its own LEA for purposes of SPED.

### COMPREHENSIVE SCHOOL-WIDE CAASPP SCHOOL IMPROVEMENT PROGRAM PRESENTATION

Mark Cruickshank, Assistant Principal, presented a program to improve CAASPP scores at the Santa Ana campus. He said 11<sup>th</sup> graders are taking interim assessments for ELA and Math. At the next professional development meeting, teachers will discuss the interim assessment reports and strategize on how to help students. Mr. Cruickshank is currently meeting with teachers twice per month to monitor student progress and adjust practices. A committee of six teachers oversees the program.

For Junior Seminar, students are strategically placed in classes where they will receive help in ELA or Math. The school has added with the help of the NOVA Academy Children's Foundation some fun student incentives for our attendance and positive incentive programs. Juniors will be rewarded with an In-N-Out truck at the end of the year if there is 100 percent attendance during CAASPP testing. There will also be incentives for highest performing and most improved.

Mark Cruickshank said teachers are reaching out to parents to communicate results. Teachers make positive phone calls every month. Olga Duarte, Board Member, said a personal, positive phone call is a great way to engage with parents.

Board Members discussed the program and commented that there should be incentives for teachers as well. Mr. Cruickshank said the school received a donation of gift cards that were being given to thank and incentivize teachers who make the most positive phone calls. Mark Cruickshank said the staff is doing a great job and they are very motivated.

Board Members asked Lisa Hernandez, Principal, to discuss what the Coachella campus is doing to improve CAASPP scores. Ms. Hernandez shared that they provided test-taking workshops and a writing campaign last year. Students attended workshops on a Saturday at a nearby college. Ms. Hernandez also shared that teachers were motivated - they enjoyed participating in the workshops. This year, the Coachella campus will provide testing workshops on Saturdays again and will also provide workshops afterschool. The Board of Directors recommended that Lisa Hernandez and Mark Cruickshank work together to share strategies.
