The results showed that Parent University enrollment participation increased, dual enrollment in college courses increased, graduation rate increased, and the rating for school climate increased. Preliminary scores in Math and English decreased. The Board discussed the importance of the principals presenting an academic plan for improvement with goals and the need for more support in Math courses. Susan Garrett, Board Co-Chair, recommended assessing students in Math every year to see improvement and benchmark. Renee added that more support Math courses were added for Coachella. In addition, both schools will implement a new assessment program that will allow teachers to develop benchmarks.
