EXECUTIVE REPORT

For the Executive Report, Renee Lancaster shared a presentation on California's Blueprint for a Safer Economy and discussed NOVA Academy's reopening plan. She described some of the school's current safety measures, such as purchasing partitions for all classrooms, "hands-free" door handle adaptors, sanitizers, ventilation filter replacements, and signage on COVID-19 safety. In preparation for school reopening, the Coachella and Santa Ana Principals asked families to complete a survey for their input. Ms. Lancaster discussed some of the struggles students are experiencing with distance learning, such as unreliable internet and feelings of isolation. There is data that shows that the best thing for students is to be at school.

Assuming that all goes as expected in Orange and Riverside Counties regarding their Tier placement, NOVA Academy will reopen for hybrid and in-school instruction on October 26. Students returning to campus will be staggered. Renee Lancaster added that the school would extend its meal program, offering more meals to students and their families. She said they received a waiver to serve more food to families without cost to the school. Additionally, Ms. Lancaster said teachers, staff, and students would be able to receive free COVID-19 testing at fifty designated testing sites.

Board Members said they are appreciative of everyone's hard work. They know it has been a difficult road. They also realize teachers are concerned and frustrated with all of the things they have to go through. Coming back is emotional, but this will be a new way of connecting with students. Dr. Sanford Otsuji said he appreciates the Board for their participation as they have had several Board Meetings in the past few months. Renee Lancaster thanked the Board for their support. The next Board of Directors Meeting is scheduled for Thursday, October 22.
