INCREASE CERTIFICATED AND NON-CERTIFICATED SALARY SCHEDULE

Renee Lancaster, CEO/Founder, presented the agenda item to increase the certificated and non-certificated salary schedule for NOVA Academy-Coachella and NOVA Academy-Santa Ana. On October 26, 2018, the school held a Board Study Session where the Board reviewed the school's long-term sustainability with five-year financial projections. At the meeting, the Board had agreed that both campus budgets would allow a 7% pay increase for certificated and non-certificated staff and a 4% pay increase for administrators. The budget included all costs with conservative enrollment projections. The school will still meet the required bond ratio.

Staff will receive the pay increase in December 2018, retroactive from July 1, 2018.

INCREASE ADMINISTRATION SALARY SCHEDULE

The Board discussed the pay increase for administrators and agreed that it should be incentive-based. Administrators include the Chief Business Officer, Director of Human Resources & Operations, Principals, Assistant Principal, and one administrative counselor. The Board requested that administrators receive a 4% pay increase in December 2018 and get up to a 3% performance-incentive pay increase in October 2019. Incentives can be goals in retention, enrollment, CAASSP performance, and college enrollment. The Board asked the CEO to determine the criteria for meeting the goals and report the requirements to the Board at a future Board Meeting. The pay increase will exclude the Director of Family Engagement & Community Involvement since this position has its own salary schedule based on performance goals.
