EXECUTIVE REPORT

Renee Lancaster, CEO, announced that NOVA Academy-Santa Ana was named a 2019 California Distinguished School. For the award, the California Department of Education reviewed NOVA's performance and progress data on the California School Dashboard. NOVA Academy submitted an application with data, a Model Program and Practices Overview, and a picture of the school. Trevor Garrett, grant writer for the NOVA Academy Children's Foundation, assisted in completing the application. NOVA Academy has received a positive response from the local community. Supervisor Andrew Do reached out to congratulate the school; he will visit the campus next week. There will be a California School Recognition Program Awards ceremony on April 5, 2019, at the Disneyland Hotel in Anaheim. Renee Lancaster, Andrea Brumbaugh, Principal, members of the NOVA Academy Board of Directors, and some NOVA Academy students will attend the awards ceremony.

The school will have an annual review from Standard & Poor's for the bond.

Ms. Lancaster informed the Board of upcoming campus events for Santa Ana. Santa Ana will have its first talent show, Spring Showcase, on May 17. There will be a Teacher Appreciation event on May 10

for Santa Ana and May 1 for Coachella. Senior Exit Interviews will be held on April 26 in Santa Ana and May 1 for Coachella. Santa Ana's graduation will be on May 30; Coachella will have its ceremony on May 29.

Lisa Hernandez, Principal, presented the campus updates for NOVA Academy-Coachella. She reported that enrollment is at 220. This month the attendance rate is 94%. There is a Principal's Lunch coming up for students on the Principals List. Students who earned 4.0 or higher in a semester earn this status. There were 34 students last semester who made the list; students of any grade can be on the list and attend the Principals Lunch. SBAC practice testing is scheduled for March 12 and 14. Students are looking forward to a staff basketball game that is coming up. Ms. Hernandez said the Coachella campus is currently researching food vendors. They are in a period of Intent to Return, which is March 1-15. Their Intent to Enroll period will be March 8-May 7.

Ms. Hernandez presented on Coachella's new academic task force to help students increase their CAASPP scores. With four teachers on the committee, the school will host student workshops on March 9, March 23, and April 16. In addition to reviewing the subject material, students will work on test-taking strategies. In the last workshop on April 16, students will participate in "Academic Olympics" to build competition and excitement. As an incentive, the school will get a taco truck if there is 100% attendance during testing week.

The Board expressed excitement for Coachella's new academic campaign and they commended Ms. Hernandez's presentation.
