EXECUTIVE REPORT

Lisa Hernandez, Principal, presented updates on the Coachella campus. She reported that Coachella's preliminary CAASPP scores came in. The scores jumped 30 points in English and 16 points in math. Students had put in extra effort to prepare, such as attending test-taking workshops on Saturdays. Dr. Sanford Otsuji, Board Chairman, and the rest of the Board congratulated Ms. Hernandez on this accomplishment.

Lisa Hernandez went on to report that the Coachella campus recently had their Senior Exit Interviews, a Teacher Appreciation event, and Prom. She presented a slide show with pictures from the events. She said the students are happy about a recent donation from a local flooring company. The company donated outdoor flooring to the campus so students can play soccer. Ms. Hernandez reminded the Board that Coachella's graduation ceremony is coming up on May 29.

Renee Lancaster, Chief Executive Officer, reported on recent updates for the Santa Ana campus. She said Santa Ana received its preliminary CAASPP scores and there was an increase in math. The Santa

Ana campus had several recent events, including Senior Exit Interviews, a Talent Show, and a Teacher Appreciation event. The graduation ceremony for the Santa Ana campus will be held on May 30.
