2021-2022 SALARY SCHEDULES – MINIMUM WAGE INCREASE

Alicia Lewis, Business Services Manager, presented the 2021-2022 Salary Schedules – Minimum Wage Increase for Board approval. Effective January 1, 2022, the minimum wage in California for employers with twenty-six employees or more will go up to \$15 per hour. Ms. Lewis said they eliminated a couple

of ranges at or below minimum wage to meet compliance. There are slight increases in the earliest steps or classes with the updated salary schedules, but there is not much of a change for payroll. There are no employees on the ranges that were eliminated.

2021-2022 SALARY SCHEDULES – PROPOSED 3% SALARY SCHEDULE INCREASE

Next, Alicia Lewis presented the 2021-2022 Salary Schedules — Proposed 3% Salary Schedule Increase for Board approval. If approved, the proposed salary schedules will supersede the salary schedules with the minimum wage increase the Board just approved. The salary schedules with the salary increase are the same as the schedules with the minimum wage increase, but with a 3% salary increase. Alicia Lewis said the administrative team reviewed the budget to ensure the school can sustain the wage increase. Carla Skaggs, Business Consultant, added that they made a five-year budget projection, which is two years beyond the state's requirement. She said five years is a long time, but they did it to make sure they could sustain the increase.

Board Members agreed with the school's decision to increase salaries. They shared that it is important for retaining good teachers and being competitive. The Board asked if they have the actual numbers on what it would cost the school. Alicia Lewis said the impact is \$79,000 per year for Santa Ana and \$54,000 per year for Coachella.

EXPANDED LEARNING OPPORTUNITIES (ELO) PLAN

Renee Lancaster and Alicia Lewis presented the Expanded Learning Opportunities (ELO) Plan for the Coachella and Santa Ana campuses. If approved by the Board, the school can apply for a grant opportunity as part of California's AB 86. Schools can use the funds to help close the learning gap students suffered from not receiving in-person instruction this past school year. The requirement is that 10 percent of funding goes toward hiring and maintaining full-time paraprofessionals. Renee Lancaster said she and her team met with different stakeholders, including administrators and parents. As part of the plan, for example, the school has extended summer school from three weeks to five weeks, and there will be twice the amount of teachers teaching summer school.

BID PROPOSALS FOR PARKING LOT GRADING AND PAVING FOR NOVA ACADEMY-COACHELLA
